

FIFTH ADMISSION NOTIFICATION FOR VACANT SEATS

The following seats are vacant for **B.A., LL.B. (Hons.) 2026- 31** Programme at Maharashtra National Law University Mumbai for the Academic year 2026-27.

Vacant Seats Admission Instruction

The allocation of vacant seats shall be done strictly according to the All India Rank (AIR) merit, for the above categories without any exceptions or deviations.

Please read the following instructions carefully to ensure a smooth application process.

4. MH-ST Category (First Preference):

For admission to the B.A. LL.B. (Hons.) Programme 2026, first preference shall be given to candidates belonging to the Maharashtra Scheduled Tribe (MH-ST) category, as the seat is reserved for the MH-ST category. There is no restriction on the All India Rank (AIR) for candidates applying under the MH-ST category.

5. MH-SC Category (Second Preference):

If no eligible applications are received from the MH-ST category, the vacant seat shall be offered to candidates belonging to the Maharashtra Scheduled Caste (MH-SC) category, in accordance with their All India Merit Rank (AIR). There is no restriction on the All India Rank (AIR) for candidates applying under the MH-SC category.

6. MH-General Category (Third Preference):

If no eligible applications are received from either the MH-ST or MH-SC categories, the vacant seat shall be offered to candidates belonging to the Maharashtra General category in accordance with their All India Merit Rank (AIR). Candidates applying under the Maharashtra General category must:

- possess a valid Maharashtra Domicile Certificate; and
- have an All India Rank (AIR) between 1 and 2000 (inclusive).



2. **Waitlist Seats:** If any of the seats mentioned above become vacant at a later stage, they will be allotted to candidates on the waiting list in accordance with the prescribed admission procedure. Subject to applicable rules and eligibility criteria.

INSTRUCTION TO CANDIDATES:

13. Application Form (**Annexure-A**) is available at [CLICK HERE](#) Application under any other mode will not be entertained. Candidates who have appeared for CLAT 2026 and are desirous of taking admission in B.A.,LL.B. (Hons.) 2026 at MNLU Mumbai under vacant categories should make an application in the above mentioned proforma (Annexure-A) expressing their interest in seeking admission for the academic year 2026-31.
14. Candidates must submit the prescribed **Google Form** within the stipulated deadline. Applications for which the Google Form is not submitted on or before the specified closing date and time shall be treated as **ineligible** and will not be considered for admission.

No requests for late submission, extension of the deadline, or any other exception shall be entertained under any circumstances.

Please note that **applications submitted through email or any other mode will not be accepted. Only applications submitted through the prescribed Google Form will be considered.**

PLEASE NOTE:- After filling out the Google form, you are requested to merge all the above-mentioned documents into a single PDF file and email the same to admission@mnlumumbai.edu.in for verification and further necessary action and subject to email document for B.A. LL.B 2026.

16. Candidates are requested to pay prescribed fee of Rs. 1,000/- per application through PayTM towards application processing fees. (Once paid, the application fee shall not be refunded under any circumstances.)

17. Applications will be considered strictly based on CLAT 2026 All India merit rank (AIR) and fulfilling all the requirements as stated in this notification.
18. The University shall not be responsible for any electronic delay or default.
19. **Last date to apply is 02nd August 2026, 11.59 PM.**
20. The result for vacant seats is tentatively scheduled to be published on 06th August 2026. However, the date may be revised depending upon the number of applications received and the time required for scrutiny and verification of applications and documents.
21. Candidates who have already applied under the category for the 1st to 04th vacant seat will not be considered for this 5th vacant seat. Such candidates are required to submit a fresh application for this vacancy.

In short, the order of allocation is:

4. MH-ST (original reserved category)
5. MH-SC (if no MH-ST applicants)
6. Maharashtra General category candidates with a valid Maharashtra Domicile Certificate (if neither MH-ST nor MH-SC applicants are available).

The reason for this change is that the **MH-ST seats remained vacant even after being advertised for the third time**, so the institution is following the applicable Maharashtra Government Resolution as per the University Rules.

22. Classes start from 3rd of August 2026.
23. In case of withdrawal or cancellation of admission, the fee refund shall be processed in accordance with the **Fee Refund Policy 2026–27**. Candidates are advised to refer to the Fee Refund Policy available on the **MNLU Mumbai website** for detailed terms and conditions.
24. **PLEASE NOTE:** Kindly read the notification carefully and apply only if you fulfill the eligibility criteria.
