The Vice-Chancellor exercises all powers of the Executive Council and performs all functions as may be considered necessary to give effect to the provisions of MNLU Act 2014. 2. AUTHORITIES OF THE UNIVERSITY

- The General Council

The General Council is the Chief Advisory body of the University. The Council comprises distinguished jurists, eminent educationists and administrators at the national level. The Chancellor is the Chairman and the Vice-Chancellor is the Secretary to the General Council.

- The Executive Council

The Executive Council is the Chief Executive body of the University. The Vice-Chancellor is the Chairperson and senior members of the judiciary, administration and academia are its members.

- The Academic Council

All academic matters of the University are regulated by the Academic Council headed by the Vice-Chancellor. It is empowered with the control and maintenance of standards of instruction, education and examination of the University.

- The Finance Committee

The Finance Committee is authorized to control and monitor the financial affairs of the University. It oversees the incoming and outgo of University funds and keeps strict vigil over proper custody of public money. The Vice-Chancellor is the Chairperson of the Finance Committee.

4. LIBRARY

The inception of the Maharashtra National Law University Mumbai Library took place on 1 August 2015 with the inaugural of its parent organization Maharashtra National Law University Mumbai. The Library strives to build a repository of knowledge base in the form of records, reports, journal, and other documents to aid future research and learning. University library has more than 5374 books and over 892 back volume journals / Law Reports. Further, the library has secured various Indian & International Law databases such as SCC Online, Manupatra, Oxford University Press, Westlaw India, JSTOR, Hein Online. The Library has also subscribed to 11 National & International print journals. The University has also been fortunate enough to host a collection of around 6000 donated books and hardbound journals from eminent personalities such as Mr. N.Jayaraman (Advocate and former IAS Officer), Hon'ble Justice Shri Abhay Shreenivas Oka, M/s. Malvi Ranchoddas & Co, Mr. Ramabhdadran (Advocate). Additionally, Law Suite Case Reporter (software) has been installed on LL.M. and 4th year students' mobiles for study and research purpose.
