Earlier period from the academic year 2019-2020 to 2023-2024 is regularized for five year BA LL.B(Hons.) integrated degree course with existing strength of two sections of 60 students, since the college has paid the default fee and regular approval cum inspection fee.

Sir/Ma'am,

This is to bring to your kind knowledge that the Standing Committee of Legal Education Committee of Bar Council of India by virtue of its meeting held on 5th November, 2024 considered the matter of Maharashtra National Law University, Mumbai, Maharashtra.

The CLE has applied one additional section alongwith existing strength of two sections in five year BA LL.B(Hons.) integrated degree course.

After consideration, extension of approval has been granted to Maharashtra National Law University, Mumbai, Maharashtra for five year BA LL.B(Hons.) integrated degree course with intake of 2 sections of 60 students along with 1 additional section ie. total 3 sections of 60 students in each section for a period of one year i.e. for the academic year 2024-2025.
