1. INTRODUCTION:

Maharashtra National Law University Mumbai (hereinafter referred to as 'the University') established under the Maharashtra National Law University Act 2014 on 20th March 2014 invites offline proposals from reputed, experienced and financially sound organization towards the empanelment of book distributors to Knowledge Resource Centre of MNLU MUMBAI.

2. BRIEF DETAILS OF EOI:

The EOI documents can be downloaded from the university's website https://mnlumumbai.edu.in/tendernotice.php to be submitted offline. Duly filled-in documents must be submitted to the office of The Registrar, Maharashtra National Law University Mumbai, 2nd Floor, MTNL Building, Technology Street, Hiranandani Gardens, Powai, Mumbai, Maharashtra - 400076 by Speed Post/Courier NOT by hand delivery, on or before 5th January 2026 up to 05:30 PM.

EOI shall be submitted by the organization/firm (hereinafter referred to as 'the vendor) in one sealed outer envelope clearly mentioning sender's name and address, mobile number and e-mail address, along with website, if any, and superscripted as 'EOI for Empanelment of book distributors.

The prescribed EOI fee and Earnest Money Deposit (EMD), as mentioned in the EOI document, shall be sent with your offer through Demand Draft (DD) drawn in favor of "Maharashtra National Law University Mumbai", payable at Mumbai. Any subsequent amendments in the EOI will be available on the above-mentioned website.

3.CONTRACT PERIOD:

This empanelment will be valid initially for (02) two year and May be extended up to (05) five years at a time depending upon the satisfactory performance of the empanelment vendor(s)/ suppliers (s) agents/distributors (s), at the sole discretion of the university.

5. ELIGIBILITY CRITERIA:

(Proof/Supporting documents to be enclosed in support of eligibility criteria mentioned below)

- (i) The Vendor shall be registered under any State or Central Government (attach copy of registration) Act as mentioned below:
 - ➤ The Companies Act 2013 (Earlier the Companies Act, 1956).
 - ➤ Indian Partnership Act 1932.
 - ➤ any other Act
- (ii) If the vendor is a Partnership Firm, registered under the Indian Partnership Act, of 1932, please state whether the partnership agreement/deed has been conferred on the partner who signed the EOI.
- (iii) The Vendor shall provide Permanent Income Tax Account No. (PAN) of the Firm with circle/ward and GST Registration Certificate (duly attested photocopy to be attached).
- (iv) The vendor shall have supplied books in the **Last Five Financial Years** as their empaneled vendor to any of the libraries of Supreme Court/High Courts/Indian Law Institute, National Law University, or/and National Level Institutions like NLUS, IITs, NITs, IISERS, and Central Universities.
- (v) The vendor shall be a member of the "Good offices committee"/ Federation of Publishers & Booksellers Association of India (FPBAI) or any other national association of booksellers and proof to this effect has to be enclosed.
- (vi) The vendor shall be an authorized distributor/dealer/ supplier of academic book publishers.
- (vii)The Vendor shall be a distributor/dealer of any of the foreign publishers like Lexis Nexis, Sage, Oxford, Routledge, Thomsons & Reuters, Sweet & Maxwell, Springer, Wiley, Oxford, Cambridge, Pearson, MGH etc. and proof of this effect has to be

enclosed.

- (viii) Average Annual financial turnover from the same business shall be at **Least 05 Lakhs during last three financial years (FY 2024-25,2023-24,2022-23).** Copy of P&L Accounts, Balance Sheets duly certified by the Chartered Accountant should be submitted in support of this along with ITRS of the above financial years. Chartered Accountant certificate duly mentioned turnover, Profit & Loss for the last 3 FYs
- (ix) The vendor shall provide a list of agencies (Government/Statutory bodies/Professional, educational institutions/state /central universities) to which they have satisfactorily supplied the books along with annual sales turnover for the last three years of those agencies.
- (x) The vendor shall give a self-declaration certificate for acceptance of all terms and conditions of EOI documents. A duly completed certificate to this effect is to be submitted as per **Annexure A.**
- (xi) The vendor should be neither blacklisted by any government department nor there should be any criminal case registered/pending against it or its owner/partners anywhere in India. A duly completed certificate to this effect is to be submitted as per Annexure C.

6. INSTRUCTIONS: -

- (i) The response shall be signed by an authorized signatory of the vendor(s) bearing his full name and status, clearly indicated below the signature along with the official seal of the firm.
- (ii) Incomplete and conditional responses shall not be considered.
- (iii) At any given point of time, if any of the documents furnished by the vendor(s)/supplier(s) is found to be false, it would be deemed to be a breach of terms of contract making the concerned firm liable for legal action, besides termination of empanelment.
- (iv) Responses received after the deadline will not be considered.
- (v) The responses will be scrutinized and shortlisted by a committee duly constituted by the Competent Authority of the University. The shortlisted vendor(s)/supplier(s) will then be required to be present at the University for personal interaction on a date, which will be informed by email.
- (vi) The short-listed vendor(s)/distributor(s)/supplier(s), at the time of personal interaction, are required to, agree to supply books as per the University's "Terms & Conditions for Supply of Books" as stipulated here.

SECTION - II

Empanelment for supply of books will be governed by the following "Terms and Conditions"

A. General

- 1. The Vice Chancellor MNLU Mumbai reserves the right to approve or reject any or all the vendors, whose decision will be final in all cases in respect of acceptance/rejection/arbitration.
- 2. Library, MNLU Mumbai reserves the right to add and/or drop any vendor to/from its empaneled list, and/or to place purchase order(s) with any vendor(s) at any time, with the approval of Competent Authority.

B. Pre - Order enquiry

- 1. The library will send a "**Pre order Inquiry**" by email which will consist of all the required details to be provided, to all the empaneled vendors, for the required list of books.
- 2. The empaneled vendors have to respond with the details inquired for, within
- 3. Three (03) working days from the date of receipt of the "Pre-order Inquiry", by email only.
- 4. All the details inquired for must be provided. If any field is left blank, the response will not be considered.

C. Purchase Order

- 1. Purchase Order will be issued by Library with all the Terms & Conditions mentioned in it.
- 2. The Purchase Orders will be issued to selected vendors based on the criteria decided by Library.
- 3. Supply of books has to be made strictly against the purchase orders only. Vendors need to strictly adhere to these Terms & Conditions in Purchase Orders. Sending an acknowledgment of the receipt of purchase order, which is taken as
- 4. an acceptance of the purchase order, is mandatory, by email only.

D. Supply Time

 The turnaround time committed by the vendor at the time of pre-order inquiry is considered in the first place. Otherwise, 5-6 weeks and 10-15 days for Foreign & Indian publications respectively is the set, general maximum time-frame for meeting the supply.

- 2. If the requested title(s) is "Out of Print" (OOP), "Out of Stock" (OOS) or "Print on Demand" (POD), sufficient valid supporting documentary proof should accompany with the request letter for extension of time.
- 3. In case of titles that are not supplied, a certificate of non-availability of those titles in the market from the publisher/publisher's distributor/stockiest should be furnished within the due date of supply.
- 4. In case there is a delay that is foreseen in supply, the concerned empaneled vendor should send a request for extension of time with reasons and proof for delay in supply, at least, **five (05) working days** before due date of supply. Competent Authorities decision would be final to provide extension or cancel the order.
- 5. If the provided reason for delay is justified with adequate proof e.g., communication from publisher/publisher's distributor or stockiest, the library may consider extension of time as may deem fit.
- 6. The supply should be free of freight charges. Supply must be made either by Postal Services or Courier Service only. Every supply should be accompanied by a delivery challan, clearly bearing the details of the items and titles in supply and their quantity.
- 7. Single invoice (3 copies) should be sent for one Purchase Order once the order is completed. Multiple invoices for single Purchase Order will not be accepted. Additionally, the titles in invoice should be according to the serial no's in Purchase Order.

E. Condition for cancellation of released Purchase Order

1.If the empaneled vendor(s) to whom the order has been placed, fails to supply the entire order or any part of the order thereof, within the stipulated time without sending any written communication and proof to the library regarding delay or his inability to supply the ordered title(s), then the order will stand cancelled and the University reserves the right to drop the vendor from its empaneled list after providing him one opportunity to represent his case. The decision of accepting supply of cancelled titles is at the sole discretion of the library and the decision of the Competent Authority shall be final.

F. Edition Specifications

- 1. Latest editions of books shall be supplied;
- 2. By default, paperback editions of books shall be supplied;
- 3. By default, Indian editions of books shall be supplied; and
- 4. In case of unavailability of paperback and Indian editions, clarification/permission

shall be sought, preferably by email, from the library, regarding supply of the available editions in lieu of the default.

G. Discount:

- Flat 25% discount shall be provided by vendors for all Indian and Foreign publications. Vendor can offer additional discount at their discretion. But not in any case provided discount should be less than 25%.
- 2. In case for any title if vendor is unable to provide minimum of 25% of discount for any title, they should specify the same in their quotation. Decision of the Competent Authority shall be final in this regard whether to accept less discount offered by vendor.
- 3. For Government Publications discount may be applicable.

H. Invoicing Procedure and Conversion Rate

- 1. The Invoice shall bear the firm's IT PAN. Pre-receipted invoice(s)/bill(s) are to be submitted in triplicate (3 copies).
- 2. A revenue stamp shall be affixed on the original bill and should be signed by authorized signatory.
- 3. Invoice shall be raised in favor of The Registrar, Maharashtra National Law University Mumbai.
- 4. One invoice shall be raised against one purchase order (P. O.) only and as per serial no's in Purchase Order. Titles from different P.O.s should not be combined and supplied under one invoice.
- 5. The prices in the invoice shall be indicated in original currencies.
- 6. If there is increase in quoted price, then the price proof of the same shall be attached along with invoice

- ➤ Rate of exchange shall be as applicable on the date of Purchase order only and should also be clearly indicated on the invoice.
- > Every invoice should certify the following:
- 1. The prices charged in this invoice are the actual, current publisher's prices as billed to us; and are true and correct.
- 2. The prices charged are as per the publisher's invoice

- 3. The latest editions have been supplied, and they are not remaindered titles.
- **4.** The books supplied against this order have been checked against defects in collation, binding, and condition of accompanying material viz., CDs etc., and for other physical conditions. If any defects are detected later, the defective books/CDs shall be replaced free of cost, at the destination of supply.

I. Defective Books & Reverse Pickup:

Reverse pick-up of the defective **Books** is the responsibility of the vendor(s) and the charges are to be borne by the vendors(s) only. Reverse pick-up of the defective **Books** must be arranged for, within 30 days of receiving intimation from Library.

- > Mandatory enclosures with Invoice.
- A copy of publisher's/distributor's invoice/copy of printed catalogue of the order period, as a price proof.
 - a. A currency conversion proof with date.
 - b. Every price proof and currency conversion proof should contain seal and authorized signature of the vendor.

SECTION - III

Termination of Empanelment:

The University shall be at liberty to terminate the empanelment of an empaneled vendor(s)/supplier(s) without any prior notice and drop the said firm from its panel in case of occurrence of any of the following events:

In case of breach of any terms of agreement, or unsatisfactory / inefficient working on the part of the vendor.

If the vendor fails to deliver at least 75% of the supply (in terms of number of titles ordered) during a year.

If at any time, found that the information provided by the empaneled vendor in any form about publications, services and related matters are incorrect and result in losses in any form to the University.

The University shall also reserve the right to claim the amount of loss incurred by the University, based on the available invoices submitted by that empaneled vendor(s)/supplier(s).

The University reserves the right to change or modify or amend or substitute any clause(s) in the "Terms and Conditions", if required, at any time.

All disputes and differences arising out or concerning the work shall be subject to the sole arbitration of Vice Chancellor, MNLU Mumbai or his nominee. The decision of

the arbitration shall be final & binding on both the parties. The empanelment will be interpreted under Indian Laws and disputes adjustable within the jurisdiction of court of law.

- (2) All documents from Sr. No. (i) to (xi) shall be submitted by the bidder correctly and completely, otherwise the bid shall be rejected by the University. Even though the bidder meets the above qualifying criteria, it is liable to be disqualified if it has made misleading or false representation in the Statements, attachments submitted as proof in support of the qualification requirements.
- (3) Financial Bid in respect of Indian & foreign publication shall be submitted in the format prescribed at Section-V.

- (4) Financial bids of only those bidders, whose bids are found technically qualified, by the Technical Evaluation Committee, shall be opened in the presence of the representatives of the bidders in the office of the University.
- (5) The Successfully Bidder is mandatory to submit the Security Deposit of Rs. 30,000/- the Security deposit will be refundable back on the completion of Contract Period.

1. EVALUATION PROCESS AND AWARD OF CONTRACT:

(1) The bids received from the bidders will be evaluated on lowest bid basis, by the Committee constituted by the University and as per the following criteria:
