#### FAQ ( Frequently Asked Questions )

### Q1. What is special about this LL.M. Program in Investment and Securities Laws?

The LL.M. program in investment and securities Laws is an advanced program of legal study that is customized to the needs of the individual student and working legal professionals. Having professional expertise in the field of securities markets and Committed to provide the highest quality of education in the field of securities markets, the National Institute of Securities Markets (Hereinafter referred as NISM, an educational institute established by SEBI) has entered into collaboration with India's premier Law university, Maharashtra National Law University, Mumbai (Hereinafter referred as MNLU) for offering this LL.M. program in Investment and Securities Laws. NISM is equipped with modern infrastructure, including simulation lab, which helps the students in developing the deeper understanding of working of the financial markets. Further, the course has been designed under the guidance of financial and legal experts of the country and delivered with the help of a faculty team mix of academia, industry expert, regulators and others. The course will also engage some of the nation's leading advocates in the field of corporate law and securities laws, as well as officers from regulators, whose work is oriented more toward practice and the profession as a visiting faculty. Dedicated to enhancing an interdisciplinary legal and securities market education for the academic community, as well as for experienced legal and business practitioners related to financial markets, the course provides a scope to the sharpening of skills and learning the tools to be an effective business lawyer.

# Q2. What are the Academic Eligibility Criteria for the LL.M. program?

#### Graduation

Eligibility Criteria for the students:

An LL.B. Degree or an equivalent examination with a minimum of Fifty percent (50%) of marks or its equivalent grade in case of candidates belonging to General/OBC/PWD/NRI/PIO/OCI categories and Forty-Five percent (45%) of marks or its equivalent grade in case of candidates belonging to SC/ST categories. Candidates appearing/awaiting results of the qualifying examination can also apply and appear in the Entrance Test. However, the eligibility by such candidates shall have to be obtained by the cut-off date which will be notified along with the Notification of

Entrance Test result, and in case such candidate is placed in compartment in the year of the admission would be treated as ineligible.

#### Additional Eligibility Criteria for Industry/ Industry Sponsored Candidates

Industry/Industry sponsored Candidates: The candidates who are working with the Regulators (SEBI, RBI, PFRDA, IRDA, IBBI, CCI etc.), Market Infrastructure Institutions (NSE, BSE, MCX, NSDL, CDSL etc.), Banks and Financial Institutions, Securities Market Intermediaries, Government Departments, Judiciary and Advocates for a period of three years and above are eligible to apply under this category.

# The other criteria regarding the eligibility for admission for the industry/industry sponsored candidates will be the same as applicable to the other candidates.

#### Mandatory: Appearance in All India Entrance Examination

The candidates should appear in all India entrance examination conducted jointly by NISM and MNLU. The test will be conducted at the following centers.

- 2. Navi Mumbai
- 3. Pune
- 4. Chennai
- 5. New Delhi
- 6. Lucknow
- 7. Bengaluru
- 8. Hyderabad
- 9. Kolkata
- 10.Ghuwahati
- 11. Jaipur

For Industry/ Industry sponsored candidates, a separate admission test/ interview will be conducted at Mumbai, New Delhi, Kolkata and Chennai.

However, the final locations will be decided based on the number of applicants.

# Q3. Is this entrance examination separate from CLAT examination conducted by NLU for admission in the regular LL.M. Program?

Yes, this examination is separate from CLAT examination. Candidates need to fill a separate form and go through a different all India entrance examination.

# Q4. Those who are in Last year and waiting for final results, can they apply?

Yes. Applicants in the last year of degree and those who have completed the degree but are wait for their final results of the bachelor's degree can also apply. Admission will be provisional till graduation marks are submitted. However, the candidate must obtain minimum percentage of marks required for the admission in their qualifying examination.

#### Q5. Who should participate for LL.M. Programme?

The programme is designed for students pursuing LL.B. three years and LL.B. five year course as well as legal professionals working in an Industry. Advocates practicing in courts are also eligible to appear in this examination subject to fulfilment of minimum eligibility criteria.

#### Q6. What is the total number of seats in the LL.M. Program?

It is proposed to have total 60 seats asunder;

- 30 seats for students under All India and Maharashtra
- 20 seats for Industry/Industry sponsored candidates
- 10 Seats (under NRI/ NRI Sponsored quota)
- In case seats under any of the above categories remained vacant such seats will be allotted to the candidates falling in any of the above mentioned categories waitlist.

#### Q7. What is the syllabus of the entrance exam of LL.M. Program?

The admission test will comprise of 100 marks questions with equal weightage drawn from each of the following subjects:

- i) Constitutional Law
- ii) Jurisprudence
- iii) Current Affairs
- iv) Law of Contracts
- v) Corporate Law

### Q8. Weather the LL.M. degree is recognized by other universities for pursuing higher studies and for the government jobs?

After successful completion of course, the LL.M. degree will be awarded by MNLU, Mumbai, which is duly recognized for pursuing higher studies and for the government jobs.

### **Q9.** Whether there will be separate classes for the industry sponsored candidates?

No, there will not be any separate classes for the industry sponsored candidates. However, they can commute from their offices/home to attend the classes. For them, requirement for a mandatory stay in the campus is relaxed.

#### **Q10.** What is the Selection Process of LL.M. course?

As per the requirements, admission to one-year LL.M. degree shall be done through a separate all India admission test conducted every year by the MNLU and NISM jointly. For the sponsored and institutional candidates, it will be through a separate test/ interview process.

#### Q11. Is distance learning available for LL.M.?

Distance learning is not available for this LL.M. Program as it's a 1-year full time residential program.

#### Q12. Is there any upper age Limit for the Program ?

No, there is no upper age limit for the program.

#### Q13. How can I apply?

Candidates are required to register themselves online on <u>www.nism.ac.in</u>

#### Step 1: New Registration:

Upon successful registration, a User-ID and Password will be sent to registered email ID and mobile number of the candidate.

#### Step 2: Application process:

Thereafter, candidates are required to log in and complete the application process by paying the registration fee. After making the payment of application fee of Rs 1000/-\* the candidates are allowed to submit their application.

#### Q14. What is the application form fee?

Students can apply Online. The online procedure has to be done by paying the application form fee of Rs. 1000 by any of these: – Debit Card/Credit Card/Net banking.
