#### **Instructions to the Candidate**

The Foreign National/NRI/NRI Sponsored candidates are required to attach the following documents along with their application forms:

# 1. Documents to be attached with application form

## (i) Non-Resident Indians

- a) Marks sheet of XII class or equivalent certificate. Candidates who have passed the qualifying examination from a country other than India are required to submit a certificate from the Indian Embassy/Indian Consulate or Association of Indian Universities, New Delhi to the effect that the examination passed is equivalent to the qualifying examination of Indian System.
- b) Copy of CLAT 2025 Score Card.
- c) Copy of the Passport of parent working abroad.(Notarized)
- d) Valid NRI status certificate issued by the Indian consulate/ Embassy abroad in the prescribed format/ notarized copy of valid PIO / OCI card.
- e) Copy of the Birth Certificate
- f) Copy of admission fee payment.
- g) Copy of LL.B. Degree and final transcript. (for candidates applying to LL.M. programme).

### (ii) NRI Sponsored

- a) Marks sheet of XII class or equivalent certificate. Candidates who have passed the qualifying examination from a country other than India are required to submit a certificate from the Indian Embassy/Indian Consulate or Association of Indian Universities, New Delhi to the effect that the examination passed is equivalent to the qualifying examination of Indian System.
  - b) Copy of CLAT 2025 Score card
  - c) Copy of the Passport of Sponsor working abroad. (Notarized)
  - d) Valid NRI status certificate of sponsor issued by the Indian consulate/ Embassy in abroad in prescribed format or Notarized copy of PIO / OCI card.
  - e) Signed Undertaking of the sponsor for financial support for entire duration of the course (in prescribed format).
  - f) Copy of the Birth Certificate of Applicant.
  - g) Copy of admission fee payment.
  - h) Copy of LL.B. Degree and final transcript. (for candidates applying to LL.M. programme).

# (iii) Foreign National Candidates

- a) Marks/Grade sheet of XII class or equivalent high school/K12 certificate. Candidates who have passed the qualifying examination from a country other than India are required to submit a certificate from the Indian Embassy/Indian Consulate or Association of Indian Universities, New Delhi to the effect that the examination passed is equivalent to the qualifying examination of Indian System.
- b) Copy of Valid Passport issued by Foreign Embassy ( Attested by Public Notary or Apostille)
- c) Copy of the Birth Certificate
- d) One passport size photograph pasted on the Application Form  $\,$
- e) A **Statement of Purpose (SOP)** for pursuing law in MNLU Mumbai (300-500 words).
- f) Proof of Admission Form fee payment

# (ONLY SELF ATTESTED COPIES ARE TO BE FURNISHED. NO ORIGINAL DOCUMENT NEEDS TO BE SENT AT THE TIME OF APPLICATION)

#### 2. Admission Procedure

- (i) Candidates fulfilling all eligibility conditions and making application complete with all documentation shall be considered for the admission under these categories.
- (ii) Applicants under Foreign National Category shall be interviewed by a Selection Panel appointed by the University.
- (iii) Offer of admission under these categories shall be in accordance with the merit list prepared by the Admission Committee.
- (iv) At the time of admission, true notarized copies of the document is required to be submitted. Original NRI Status certificate (if applicable) needs to be submitted.

# 3. Application

Application has to be made via Google From prescribed by the University. No other mode is permissible. Ensure that documents mentioned at **Annexure-B** should be uploaded via the Google Form prescribed.
