Maharashtra National Law University Mumbai established by Maharashtra Act No. VI of 2014 is a premier Law University established in the commercial capital city of India. The University invites applications for admission to the One year LL.M (Professional) Programme for the Academic Year 2019-20 commencing from September2019.

**Eligibility:** The LL.M. (Professional) Programme will be conducted through a mixed mode of class room teaching & virtual contact learning. A person who has completed his/her LL.B. (3 years or 5 years) and has been in service or had professional experience will be eligible to enroll for the saidprogramme.

Total Seats: 100

Reservation: As per Maharashtra Government Rules. Duration ofthe Programme: One year (2019-20)

Fee: Rs. 75,000/- (Rs. Seventy-Five Thousand only) for Indian students. USD 1500/- (USD One Thousand Five Hundred only) for Foreign Nationals.

Note: Being a professional program there is no consideration for differential fees to any category.

## Note:

- 1. LL. M (Professional) shall not qualify a candidate to the academic benefits of regular LLM degree like admission to M.Phil./Ph.D. It shall not provide eligibility for NET/SET/SLET Exams.
- 2. Benefits of the programme are as Follows:
- A) Update the subject knowledge through contemporary advancement in law and administration of justice and allied matters.
- B) To assist in giving them an upper edge in their respective profession through multidisciplinary exposures to various laws relevant in contemporary times.
- C) Can be considered for internal growth by respective organizations as per their internal policies.

Candidates for admission will be selected on the basis of percentage secured in LL.B. The merit cut-off list will accordingly be prepared for admission.
