M.A. MEDIATION AND CONFLICT RESOLUTION FOR EXECUTIVES

Mediation is a voluntary and binding process in which a fair and neutral mediator helps the parties to reach an agreement. Mediators do not force resolution but create a favorable environment where the parties can resolve all disputes. Mediation is a proven alternative to dispute resolution, where a neutral person uses specialized communication and negotiation techniques to facilitate parties in resolving their disputes. Mediation is the quick, responsive, economical, and informal mechanism leading to a Harmonious settlement. The parties to a mediation have absolute control over the proceedings and end up in a win-win situation for all. There is no doubt that mediation has had a significant impact on dispute resolution all over the world. In Bangladesh, mediation has been highly successful in delivering justice to the poor sections of society. In America, mediation is the norm for dispute resolution and litigation is the exception. In England, the courts do not award costs if a litigant unreasonably rejects mediation as an alternative dispute resolution mechanism. In India, mediation has been part of our social life from time immemorial though structured mediation is a recent development in the Indian system. Mediation showed significant results in dispute settlement in India. Encouraged by its success, the Government of India is in the process of making comprehensive legislation governing mediation. There is considerable demand and space for skilled mediators in India. Responding to the needs of the profession and industry, Maharashtra National Law University has launched a 2 year M.A. program in Mediation and Conflict Resolution for Executives in the year 2020-21. As a noble program, we got a tremendous response and over the five years, the program has evolved and developed into a popular academic program. Based on the experience and feedback of the first four batches, the university has completely restructured and reformed the program by transforming it into a full-fledged and highly packed P.G. program in mediation. It is proposed to offer the restructured program for 2025-27.



ABOUT THE PROGRAM

The M.A. (Mediation and Conflict Resolution) is introduced to equip working professionals with an array of skills and expertise in the world of dispute resolution, as conflict is an inevitable element of our life and work. Regardless of one's professional calling, Mediation can be a significant game changer in dealing with life issues. With the skill sets it promises, the post-graduate Program will bolster participants' social and professional standings and make them more valuable personnel to the organizations and brands they represent. We have designed a highly professional program structure and syllabus that will touch on almost every aspect of mediation, conflict management, and resolution.

TOTAL NUMBER OF SEATS The total numbers of seats are 30. However, the University reserves the right to alter the number of seats for the program in a given academic year without prior notice. Note: (Reservation: As per Maharashtra Government Rules.)

ELIGIBILITY

A Degree in any discipline.

Candidates appearing in the qualifying examination in May/June 2025 are also eligible to apply.

EXAMINATION SCHEME

The evaluation of participants in the program will be continuous. Each paper will be evaluated for 100 marks as under:

Internal (50 marks): Class Participation/Presentation/Projects/Roleplays/ Reflections

External (50 marks): End Term Examination

ATTENDANCE

Participants are expected to be present in all classes. Classes will be held for a limited number of days per month, for limited hours per day, at times that are suitable for the working professional. For each semester, the academic calendar will be shared with the participants well in advance. Every student has to secure a minimum of 70% attendance in all the subjects taken individually in each semester to be eligible for appearing in the end- term examination.

NOTE In case a participant does not attend a particular class, the class recording shall be available for viewing. To be eligible for attendance for that class, class reflection question(s) will have to be answered. However, this option will be available in exceptional cases with the prior permission of the Program Director/Coordinator.

ADMISSION TIMELINE

- Last Date for Submitting Application Form: December 25, 2025
- The release of shortlisted candidates and the date of commencement of the program will be communicated shortly.

FEES AND PAYMENT DETAILS The fees for the full two-year program are ₹ 1,20,000. The Program fees are inclusive of admission fees, tuition fees, and library. It does not include lodging and boarding charges for the compulsory 06 days contact classes which shall be held at the MNLU, (Powai) Mumbai campus. The program fees may be paid in two installments. The admission fee of ₹15,000 is non-refundable. If the candidate decides to opt out of the program after paying the admission fee of ₹15,000 and the first installment of ₹45,000 towards the program fees, then only ₹45,000 shall be refundable in full, if notified within 7 days of payment.
