

It is a 'Unitary University' having greater autonomy and accountability. The University does not have any 'affiliated colleges' attached to it.



The campus location is in proximity to IIT Bombay and is 13 kms from the Chhatrapati Shivaji International Airport. The student's hostel (boys and girls) is located just across the campus. At present university functions from its rented building located in the MTNL Building.



The centrally air conditioned floors of the 'Academic block' of the university have all essential amenities like smart classrooms, library, reading room, moot court hall, mediation centre, legal service clinic, internship cell, board room and conference hall etc., ideal for optimizing the students' learning, research, training and extension activities. Doctor of Philosophy (Ph.D.)



Ph.D. Programme in Law Admission Criteria:

Admission to the Ph.D. programme is strictly based on UGC Guidelines and Ph.D. Ordinance of the MNLU. The eligibility criteria are:

- Clearing NET/SLET: Candidates who have cleared the National Eligibility Test (NET) or State Level Eligibility Test (SLET) are eligible for admission.
- Ph.D. Entrance Test (PET): Candidates who have not cleared NET/SLET can appear for an admission test conducted by MNLU Mumbai.
- Interview/Proposal Presentation: Candidates who clear the PET/admission test will be required to appear for an interview/proposal presentation.



Administrative Support – The hostel is managed by a team comprising the Chief Rector, Senior Wardens, Wardens, and administrative staff, this team oversees the daily functioning of the hostel, student welfare, room allotments, discipline enforcement, and coordination with students regarding hostel-related matters.

Medical Support:- A female physician is available at the hostel daily during designated hours to provide medical assistance to students. Additionally, three psychologist visits the university twice a day to offer mental health consultations to students. First-aid facilities and nearby hostel access in case of emergencies. There is a vehicle available with driver only for the medical emergency in the hostel.

Discipline and Safety:- Security personnel are deployed round the clock, with an attendance system maintained through night rounds and daily monitoring. Emergency contact numbers and grievance redressed mechanisms are prominently displayed within the hostel premises.

Mess facility payments will be made directly to the vendor by the university, applicable to both university and hostel premises.

Bullying Bullying is the repeated, unreasonable behavior by an individual or group, directed towards another individual or group, either physical or psychological in nature, that intimidates, offends, degrades humiliates, undermines or threatens. This includes pressuring another individual or group to do something that they are uncomfortable with.

Caste Discrimination

Caste Discrimination is treating another individual or group less favorably because of the caste they might belong to and inherent biases regarding the same.

Direct Discrimination

Direct discrimination is treating another individual or group less favorably on the basis of a protected attribute than someone without that attribute in the same circumstances or circumstances not materially different.

Indirect Discrimination

Indirect discrimination is imposing, or proposing to impose, a requirement, condition or practice that has, or is likely to have the effect of disadvantaging an individual or group with a particular protected attribute, and which is not reasonable in the circumstances.

Harassment

Harassment is any unwelcome, offensive, abusive, belittling or threatening behavior that humiliates, offends or intimidates an individual or group on the basis of a protected attribute. Note that “sexual harassment” has a specific meaning as any unwelcome sexual advance, request for sexual favors or any other unwelcome conduct of a sexual nature that humiliates, offends or intimidates a person and which a reasonable person having to all the circumstances, would anticipate making the person humiliated, Offended or intimidated.

Victimization

Victimization is to cause detriment to a person because that person has made a complaint or taken part in complaints proceedings.

Vilification

Vilification is the public incitement of hatred, contempt or severe ridicule of another individual or group on the basis of a protected attributes.

Explanation

Derogation in the otherwise normal course of events. These Protected attributes are traits and characteristics that may be the subject of ridicule or could include body- type, caste, disability, gender identity, relationship status, sexual practices or experience, political affiliations, private life, race, color, descent, ethnic origin, or ethno-religious background, religion, sexual orientation, socio-economic status, among others.
