STEPS FOR ADMISSION:

1. **All interested candidates are required to complete the Provisional Admission Form by submitting their details through the Google Form link provided above. At the time of application, candidates are required to pay only the Provisional Admission Application Fee of ₹1,000/-.**
2. **Screening and Shortlisting of Applications:** After reviewing all applications, eligible candidates will be shortlisted based on the admission criteria of the programme. Shortlisted candidates will be informed about their selection through their registered email address.
3. **Payment of Programme Fee:** Candidates who are shortlisted will receive an admission-related email containing the payment link and instructions for fee submission. The full programme fee must be paid only through the link provided in the email. Failure to pay within the stipulated time may result in cancellation of the provisional admission.
4. **Verification and Final Admission Confirmation:** Once the programme fee has been successfully paid and all required documents have been verified by the University, candidates will receive an official admission confirmation email, confirming their enrolment in the programme.

Note: The programme will commence in accordance with the academic schedule notified by the University and is subject to the fulfillment of the minimum required admissions.
